The catch is, no Commissioner is willing to file a sworn complaint against Daniela alleging a conflict of interest violation because no Commissioner believes she violated the conflicts of interest ordinance. So apparently there is no procedure to find her innocent even if the Ethics Commission believes she is, in fact, innocent.
